1. Guidelines/procedure for Internship:

- 1.1. The students will apply by filling their detailed information as per the (as Annexure-I).
- 1.2. No TA & DA will be given to the Interns, for joining the Internship programme.
- 1.3. The candidate will be required to produce a permission / recommendation letter from their head of the Institution or the Head of the Department before undertaking the internship.
- 1.4. All applications will be scrutinized and the actual offer will be sent to the selected candidates subject to the availability of slot and the approval of competent authority.
- 1.5. Knowledge of computer applications as well as excellent written and oral communication, ability to work in a dynamic environment, good comprehensive skills will be given additional weightage while selecting the Intern.
- 1.6. Intern will take all possible steps to preserve strict confidentiality regarding any information to which the intern has access through his/her work.
- 1.7. The intern will never to pass any information obtained to anyone outside, unless he/she has been directed to do so by a more senior member of staff, and the reasons for doing so are clearly understood.
- 1.8. The intern will submit a report on its work 2 weeks before the completion of the internship.
